From the President



For the last year and a half, the COVID-19 pandemic has dominated many of the conversations surrounding Austin Peay State University. It's an important topic that I'm always eager to discuss because, like many of you, I'm extremely proud of the University's herculean efforts over the last 18 months to keep our students, our University and our community safe. We pivoted to online instruction and then successfully returned to offering on-ground classes. Last fall, we drastically outperformed every other public school in the state in terms of low positive cases for COVID-19, and throughout the spring and summer, our nursing students

vaccinated thousands of area residents.

We've done some great work, but lately I've wondered if these conversations about the pandemic have overshadowed our other amazing, non-COVID-related achievements. While we spent the last year and a half working tirelessly to keep our community safe, the University has continued to excel as an academic institution and a community resource. During the pandemic, we graduated our first doctoral student – Dr. Sarah Dugger – and we launched our second doctorate – a Doctor of Psychology in counseling psychology. Those were both historic accomplishments that all alumni should view with a sense of pride.

What else did we do? We received state approval to build a new Health Professions Building on campus, and we developed Tennessee's first Institute for National Security and Military Studies. In June, the University opened a new Aviation Science Facility at the Clarksville-Montgomery County Regional Airport, and this fall, we began offering new degree programs – a Master of Science in Criminal Justice and a Bachelor of Music with a concentration in music therapy – that fill important community needs.

It's also been a year of milestones, with successful programs marking impressive anniversaries. This year, Austin Peay's Center for Excellence in Field Biology turned 35, and our award-winning Army ROTC program is celebrating its 50th anniversary.

In this issue of Austin Peay: The Magazine for Alumni and Friends of Austin Peay State University, you'll read about just a few of our incredible, non-COVID achievements during this pandemic. You'll be happy to know that Austin Peay continues to thrive, but the last 18 months did alert us – and all institutions of higher education – that we're now in a rapidly changing world.

To ensure we're prepared for this new reality, the University recently began revising its strategic plan. Part of this process will include updating our mission and vision statements. It's an exciting moment in this University's history, as we work to better serve our students and our community in this new normal while also retaining the aspects of our culture that we all know and love. 

APSU VACCINATES THOUSANDS DURING PANDEMIC

On Tuesday, March 2, Austin Peay State University's nursing faculty and students began administering the Moderna COVID-19 vaccine to members of the Montgomery County community at a drive-thru site behind the Ard Building.

Over the next few months, the University vaccinated more than 4,000 people, helping keep the local community safe during a global pandemic.

The University spent months preparing to become an official county vaccination site, with APSU's physical plant setting up vaccine tents in parking lot 11, next to the Ard Building.

Austin Peay also operates a clinical laboratory on campus for testing and vaccines. The lab has an "ultra-freeze" freezer for storing vaccines.

STATE APPROVES FUNDING FOR NEW HEALTH PROFESSIONS BUILDING

In April, the Tennessee General Assembly approved funding for 114,600-square-foot health professions building at Austin Peay State University.

"This new facility will not only transform our campus – both physically and academically – it will improve public health for our neighbors, friends and family," APSU President Mike Licari said. "Students will collaborate with others in different fields, making them better healthcare professionals, and the building will provide important public clinical space to serve different populations, including veterans and low-income citizens."

The building will allow APSU to consolidate its growing healthcare-related programs – nursing, allied health sciences, health and human performance, psychological science and counseling and social work – under one roof. Construction will begin next year, with a projected opening before the fall 2024 semester.

INSTITUTE FOR NATIONAL SECURITY & MILITARY STUDIES

State legislators agreed to fund APSU's Institute for National Security and Military Studies – the first such institute in the state. It will oversee educational programs, military outreach activities and interdisciplinary research on national security, intelligence and military life.



NEW CRIMINAL JUSTICE GRADUATE DEGREE

This fall, the Department of Criminal Justice began offering a Master of Science in Criminal Justice with an optional concentration in homeland security. APSU now offers the state's only master's program with a concentration in homeland security.



APSU AT THE AIRPORT

In June, the University unveiled its new Aviation Science Facility, along with its fleet of five helicopters, at the Clarksville-Montgomery County Regional Airport.

Chasing a dream: How Deepesh Subedi escaped a Bhutanese ethnic war and won THEC's top service award

They were coming to arrest his father. Deepesh Subedi, only five at the time, helped his family quickly pack a few essentials before the soldiers arrived. It didn't matter that his father was a quiet farmer, with no interest in politics. It didn't matter that the Subedi family had lived in Bhutan – a small country on the edge of the Himalayas – as legal citizens for several generations. All that mattered to the soldiers, marching up the slopes with their guns, was that the family had immigrated from Nepal several generations earlier.

Men were coming to arrest his father – possibly his entire family.

"We left everything in the middle of the night," Deepesh said. "We fled our home, we crossed the jungle, and we came to India for safety."

The family eventually made its way to Nepal, but it was a foreign land to them; they were not citizens of this country. After escaping an ethnic war in Bhutan, the Subedis spent the next 17 years – Deepesh's pivotal childhood years – living in an unsanitary refugee camp where, in those first few years, people regularly died of cholera and dehydration.

"A lot of people died – I have witnessed them in front of my eyes," he said. "I wanted to be a part of the solution, and now I'm chasing my dream."

Chasing that dream brought Deepesh to Austin Peay State University, where he is now a graduate student in the school's online Master of Science in Nursing program. But he has already become part of the solution, using his healthcare background to help ease suffering among Nashville's Bhutanese refugee community. Last spring, Deepesh was recognized for his work when he received the Tennessee Higher Education Commission's Harold Love Outstanding Community Service Award. The honor is given to only five college students across the state each year.

"When I see a problem, I want to be part of the solution"

As a child growing up in a refugee camp, Deepesh made a promise to himself to never let the title of "refugee" define him or prevent him from doing what he wanted with his life. It was a difficult promise to keep sometimes.

"After my high school, I was interested in the medical field so I applied to medical school," he said. "But in Nepal, to go to medical school, you have to be a citizen of the country or you have to pay your tuition up front."

In 2008, an international organization started resettling Bhutanese refugees all over the world. The Subedis decided to head to the United States. They spent the next year going through the screening process before they were finally accepted by a resettling agency in Idaho.

That's where Deepesh, enrolling at Boise State University, became the first member of his family to go to college.

"I was thinking of going to medical school, but I got married, had kids, life happened," he said. "My parents don't speak English; I have to support them. My parents are totally dependent on me."

Some of his relatives from the Nepali refugee camp made their way to Nashville, and in 2012, Deepesh and his family moved south to Music City – a more diverse city than Boise. A year later, Deepesh and his brother opened the Central Market, a South Asian grocery store on Nolensville Pike.

"When I see a problem, I want to be part of the



solution," he said. "A lot of people want ethnic food, ethnic items – our ethnicity is attached to our life. In American markets, we don't find those things we need them for festivals and celebrations, and there's so much food in our country that we don't find."

'There are no words that translate'

After a few years of running the all South Asian ethnic grocery, Deepesh decided to step back from the family business to focus on his healthcare career.

"When I first came to the United States, in Idaho, I was one of the best English speakers, so I started translating and interpreting at hospitals, schools, banks, offices," he said. "The hardest, when I was translating for the doctors or nurses, even though I'm understanding what the doctor says, there are no words that translate to the Nepali that the patient will understand. Words like 'occupational therapy,' these didn't exist."



Now living in Nashville, he enrolled at Tennessee State University and earned his Bachelor of Science in Nursing. After graduating, he started working at Southern Hills Hospital, which serves the Bhutanese community.

"For the people of my parents' generation, when I go in with my nursing uniform and stethoscope around my neck, and I greet them in Nepali, they're 10 percent better," he said. "And they will start opening up for more conversation."

'I feel so blessed'

Deepesh enrolled at Austin Peay because his goal, once he earns his nurse practitioner degree, is to open a clinic in Tennessee that serves residents with limited English language skills. But early into studies, the COVID-19 pandemic created a global emergency. In April 2020, more than 100 employees at a Tyson Foods plant became infected with the new coronavirus, and many were Nepali immigrants.

"So now I started to get calls because I'm the first one in the medical profession in the whole community," Deepesh said. "Since they've seen me in the store, and we have a relationship from a business point, they will ask, 'what should I do?'"

To help his community, he shot videos and hosted Zoom sessions about preventive measures, such as wearing a mask and social distancing. He talked to individuals about their symptoms and whether they should go to the hospital or quarantine at home.

His work led him to receive the Tennessee Higher Education Commission's top volunteer recognition. For Deepesh, his efforts don't feel like work. It's his calling.

"I feel so blessed," he said.

CENTER OF EXCELLENCE FOR FIELD BIOLOGY CELEBRATES 35TH YEAR

In 2002, as Dr. Ben Stone neared the end of his time as founding director of the Center of Excellence for Field Biology at Austin Peay State University, he shared his ruminations about our relationship with nature.

"I believe that the best thing a human being can do is try to increase understanding of nature, the entire reality – the all – around us," Stone wrote in "Land Between the Lakes, Kentucky and Tennessee: Four Decades of Tennessee Valley Authority Stewardship." "This can be done best by the techniques of the natural sciences. ... One must observe nature. "To this end, the Center for Field Biology provides one of the best opportunities in Tennessee."

In its 35th year, the center remains an opportunity for Austin Peay and beyond. Since its inception in 1986, the center has expanded from a focus on the fauna and flora of the Land Between the Lakes to establishing in 2017 the Southeastern Grasslands Initiative – which is working to restore thousands of acres of grasslands from Texas to New Jersey.

"As a result of the center's activity and the funding, this center gained both a regional and international visibility," Stone said in a spring 2021 interview. "That would never have been achieved had it not been for the state Centers of Excellence program."

The center's genesis in Land Between the Lakes

The Tennessee General Assembly and Gov. Lamar Alexander in 1984 announced the creation of a new "Centers of Excellence" program designed to build upon the research strengths of the state's universities.

"Well, you have to remember how the department was before the center ... it was a teaching department, and there was no time for research," said Dr. Wayne Chester, a biology professor at Austin Peay from 1967-2008 who also served as principal investigator for the center. "One of my mentors one time, when I was in grad school, said, 'If you're going to teach science, you'd better do some science."

The Centers of Excellence program allowed

Austin Peay's biology professors to expand on the breadth of research they already were doing at Land Between the Lakes (LBL). Some APSU biologists had been researching in LBL since 1963 at the Tennessee Valley Authority's request.

"As a result of that early work in Land Between the Lakes, we based our center on Land Between the Lakes," said Chester, who had performed field research in LBL since 1967.

During the summer of 1985, Stone and Chester joined Drs. Charles N. Boehms, William Ellis, Floyd Scott and David Snyder to develop the "Proposal for the Establishment of a Center of Excellence for the Study of Flora and Non-Game Fauna of Land Between the Lakes at Austin Peay State University."

The state established the Center of Excellence for Field Biology of Land Between the Lakes the following summer. Dr. James Fralish of Southern Illinois University at Carbondale joined Boehms, Chester, Scott and Snyder as the center's first principal investigators. Stone became the first director.

Early successes expand mission

The center quickly succeeded at its mission and earned designation in 1989 as an "Accomplished Center of Excellence," which expanded the center's scope and financial base.

One of the state's goals with the centers of excellence was "to provide external funding that would, in turn, attract external funding on the national level," Stone said. "As a result of this center faculty's activity, we brought in several million dollars in funding by the time I retired in 2002."

The center's current principal investigators – Drs. Dwayne Estes, Rebecca Johansen, C.M. Gienger and Stefan Woltmann, and Michelle Rogers – have secured about \$3 million in external grants and contracts. And since 2017, the Southeastern Grasslands Initiative has earned more than \$4.1 million in fundraising and grant money.

In its first 10 years, the center awarded more than 200 research assistantships to students. That has continued to today with an Austin Peay student recently earning APSU's first-ever National Science Foundation Graduate Research Fellowship.

"This is a great way to grow scientists, to get them started."

Also, of the 137 presentations and 52 publications produced by the center's current principal investigators, about 80 have included student researchers.

"This is a great way to grow scientists, to get them started," said Dr. Steve Hamilton, who retired as the center's director in May. "They have all the coursework, which is more regimented and structured, but to actually get in the lab and field and conduct an experiment ... is learning how science works, the nittygritty of it not just the rote memorization."

Dr. Floyd Scott - 1944-2021



Austin Peay's Center of Excellence for Field Biology lost one of its founding members, Dr. Floyd Scott, when he passed away on April 25.

"He was the closest thing to a brother that I ever had," said Dr. Eugene Wofford, a longtime botanist at the University of Tennessee, Knoxville. "He was a very kind, very compassionate person, and I miss him dearly." Wofford met Scott in 1961, when the two enrolled as freshmen – along with Floyd's brother, Lloyd – at Austin Peay.

"He was not only my friend, he was my best friend," Wofford said. "Everybody is going to miss him."

Scott was one of the team members who in 1985 wrote a proposal to establish the Center of Excellence for Field Biology at Austin Peay. In 1986, he became one of the center's original principal investigators.

Scott's work at Land Between the Lakes goes back to the 1960s when he helped Dr. David Snyder survey the reptiles and amphibians of LBL.

That work culminated in 1972's "Amphibians and Reptiles of Land Between the Lakes." Scott worked to update the book, which published with the same name in 2016.




Music Therapy



When Jennifer Denk takes out her guitar and strums a soothing melody – anything from "Amazing Grace" to "Margaritaville" – her listeners sometimes drift off to sleep. As a board-certified music therapist, that's exactly the type of reaction she wants. Denk isn't a performer; her music, played in schools, hospitals and for hospice patients, is meant to ease suffering and help listeners overcome challenges.

"I've done this for 10 years, and I'm still blown away by the power of music," she said. "Our purpose is not to teach our clients to learn an instrument or sing. We're using music to address their needs. So, we're working with motor skills, communication skills, cognitive skills, social skills and emotional skills. That's why there are so many applications of music therapy in the community."

Last August, Denk joined APSU as an assistant professor of music. Throughout the year, she's piloted a music therapy concentration within a degree program at the University, and this fall, the APSU Department of Music welcomed the first students into its new Bachelor of Music with a concentration in music therapy degree program. Austin Peay is now one of only two public schools in Tennessee to offer a music therapy degree accredited by the American Music Therapy Association.



"As a music therapist, I've worked with clients across the lifespan," Denk said. "With all the populations we work with, that means there are a lot of job opportunities. We designed our curriculum in such a way that all the information they get here can directly be applied to the field."

Music has long been a source of healing and inspiration – its therapeutic roots date back to antiquity – but according to the American Music Therapy Association, the modern profession "began after World War I and World War II when community musicians of all types, both amateur and professional, went to veterans' hospitals around the country to play for the thousands of veterans suffering both physical and emotional trauma from the wars."

This ability to serve soldiers and veterans, along with people ranging in age from preschoolers to senior citizens, is one of the reasons why the Department of Music developed this new program.

Call her Dr. Dugger: APSU's first doctoral graduate

The title in front of her name sometimes causes her to hesitate – Dr. Sarah Dugger.

"A lot of my teacher friends will joke and call me Dr. Dugger," she said.

Others might also hesitate when she tells them where she earned her doctorate – Austin Peay State University. For the last 94 years, the University has never awarded anything higher than an education specialist graduate degree, but that changed on Friday, May 7. That evening, Dugger – let's say it again, "Dr. Sarah Dugger" – made history by becoming the first person to earn a Doctor of Education (Ed.D.) in educational leadership degree at the University.

"It's very humbling," she said. "That part really didn't hit me until I finished defending my dissertation and Dr. (John) McConnell said, 'You're the first doctorate degree awarded at Austin Peay.' For the University, I think it's really cool."

"This is a significant milestone in the history and development of the Eriksson College of Education," Dr. Prentice Chandler, dean of the college, said. "Since Austin Peay started as a teacher training institution over 90 years ago, it's fitting that the first doctoral program and first doctoral graduate is in the College of Education. We are proud of Dr. Dugger's accomplishment and look forward to how this degree will change the trajectory of our college. We are just getting started."

Educational Roots

On April 25, 1927, Tennessee Gov. Austin Peay signed a bill creating a normal school on the old Southwestern Presbyterian University campus in Clarksville. This new school, named after the governor who died a few months later, was founded for training rural teachers in this area.

Over the next nine decades, as the thriving school eventually became a full university, the demand for a degree in educational leadership among the area's K-12 professionals also grew. The faculty and staff within Austin Peay's Eriksson College of Education spent a decade developing the program, and in April 2018, the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) – the region's higher education accrediting body – approved the new degree program.

The agency also reclassified Austin Peay as a Level V institution, opening the door for future doctoral degrees. In the final months of the approval process, Dr. Gary Stewart, APSU professor of education, began recruiting students for the new degree – he wanted to ensure they enrolled only the top candidates. One of the people he approached was Sarah Dugger.

Dr. Dugger

In 1986, decades before she was Dr. Dugger, she was a recent college graduate beginning her career as a public school teacher. She enjoyed teaching but she left the field to become a stay-at-home mom for her six children.

"Fast forward to 2012. I had been a stay-at-home mom for quite a few years," she said. "My husband had a traumatic brain injury and was unable to work. It was a fast turn of events that had me go back into teaching."

She took a job at Cheatham County Central High School to help support the family. Her oldest son, a communication graduate student at Austin Peay, told her about a Master of Education in Reading degree at his University. But Dugger hesitated, unsure if she wanted to become a student again.


Her son, who worked in APSU's College of Graduate Studies, took the initiative for her.

"The next thing I knew, he said, 'You need to get your transcripts and send them to the College of Graduate Studies,'" she said. "He filled out the application for me and said, 'By the way, you're taking the MAT (Miller Analogies Test) tomorrow at 8 a.m. at Cumberland University.' Four days later, my classes started."

Dugger quickly realized that she loved being a student again, so she subsequently enrolled in Austin Peay's Educational Specialist (Ed.S.) program in curriculum instruction and instructional technology. Within two years, she earned two graduate degrees from the University.

As she was finishing up her Ed.S., Stewart and McConnell kept telling her about a new doctoral degree coming to Austin Peay.

"They recruited heavily, I'll put it that way," she said.



The program

Dugger, along with 19 other educators and working professionals, enrolled in the Eriksson College of Education, forming the doctoral degree's inaugural cohort. Classes began in Fall 2018, and over the next three years, students met on Monday nights on campus and over Zoom. The community encouraged each other to continue, even when the COVID-19 pandemic disrupted their program.

"It's been a great program," Dugger said. "A lot of really practical course work, things I've been able to implement over the last three years. Great professors."

Dugger set herself the goal of finishing the degree in three years, so when she began working on her dissertation last fall, she made her own rigid research and writing deadlines. Another goal – no procrastinating.

On March 26, she successfully defended her dissertation, "The impact of COVID-19 on Risk of Teacher Retention in the United States." Then, during a socially distanced commencement ceremony in May, she received her hood and a round of applause, officially becoming "Dr. Dugger."

"And I never thought I would even pass statistics, but I aced it," she said.

50 YEARS OF ROTC



This year marks the 50th anniversary of Austin Peay's award-winning Army ROTC program. Here's a look at some of the program's milestones that occurred over the last five decades.

Jan. 28, 1971: Army General Order Number 4 authorizes Army ROTC at APSU.

Sept. 1971: Army ROTC classes begin at APSU.

Jan. 25, 1973: Michael Worsham is the first APSU cadet commissioned as an Army officer.

Mar. 14, 1975: Remo Butler ('75) is commissioned. He will become APSU's first general officer and the first black Special Forces officer to make brigadier general in June 2000.

Jun. 3, 1977: Former cadet Ronald Bailey graduates. He joins the U.S. Marines and retires as a lieutenant general.

Aug. 2, 1979: Herbert Rodriguez is the 100th cadet commissioned.

Nov. 1988: Lance Richardson ('89) is named the top Army ROTC cadet in the nation.

Nov. 1990: APSU Army ROTC program earns its first MacArthur Award.

Nov. 1991: APSU Army ROTC program earns its second MacArthur Award.

Dec. 12, 1985: 1st Lt. Kip Stevens ('84) is among the 248 soldiers killed in the Gander, Newfoundland, plane crash after a six-month peacekeeping mission in the Sinai Peninsula. **Dec. 4, 1987:** Paul Bontrager is commissioned. He will be promoted to brigadier general in August 2014.

LATINO COMMUNITY RESOURCE CENTER



For Kemeliz Fuentes, a sophomore at Austin Peay State University, being a Latina in America often means struggling to exist in two separate worlds.

"You'll ask yourself, 'Am I being American enough for my American friends and Hispanic enough for my Hispanic friends?" she said.

When these questions begin to overwhelm her, Fuentes heads to the bottom floor of the APSU Morgan University Center where, in a large office suite with couches, tables, a television and small kitchen area, she relaxes with friends dealing with similar concerns. This space, the APSU Latino Community Resource Center, is a second home for students like Fuentes, and it's helping more Latino students enroll and thrive at Austin Peay.

"I like it here because I can feel more connected to who I am," she said. "For me, it provides a sense of community to connect more with my people."

Last year, Kiah Albritton with the Education Trust of Tennessee noted that Latino Tennesseans "are largely underrepresented at many of our state's public higher education institutions." The Trust released a report – "Tennessee: Segregation Forever?" – that criticized several Tennessee schools for their inclusion efforts, but the document also praised Austin Peay for its recruitment and retention of Latino students.

"Alongside the overall growth, [Austin Peay] has maintained a focus on increasing its student of color population as well," the report stated. "The campus, which has the highest Latino access score of any public institution in the state, also enrolls more military students than all other state colleges and universities combined. One strategy in

achieving the institution's goals to increase diversity is clearly stating, prioritizing and investing resources to meet that goal."

In recent years, the center has become one of the key instruments in that strategy, which is why the University rebranded it this spring from the Hispanic Cultural Center – as it was known for 16 years – to the Latino Community Resource Center (LCRC).

"When we were the Hispanic Cultural Center, I think there was always this confusion of what we were and who we served," Yanaraliz Barnes, coordinator for the center, said. "A lot of people thought we were a club, or they thought we primarily provided tutoring for people taking Spanish, and some didn't even know we were here. We wanted to be more specific, more upfront about what's our main focus, which is to serve Latino students through resources. And so, we are now the Latino Community Resource Center."

James new men's basketball head coach

Twenty years ago, Nate James played 20 minutes for Duke in the 2001 NCAA Men's Basketball Championship game win against Arizona, earning the first of three national title rings he'd pick up as a Blue Devil – one as a player and two as an assistant coach under one of college basketball's most legendary names.

Today, he is ushering in a new era of basketball in Clarksville as the 13th head men's basketball coach in Austin Peay State University history.

"To have the opportunity to lead my own program, be part of the amazing vision for a place like APSU and serve a community that embraces its university and student-athletes has been a dream of mine for quite some time," he said last spring. "It is exactly what every coach wishes for."

The 43-year old James has basketball – and success – ingrained in him. From his time as a player

to his tenure as a coach, James has been a part of 22 regular-season, tournament or national title teams.

Thirty players in James' sphere of influence have earned All-ACC honors during his time at Duke, with 17 earning All-America honors, five earning National Freshman of the Year and two – Marvin Bagley III in 2018 and Zion Williamson in 2019 – being named National Player of the Year.

Young new women's basketball head coach

Last spring, Austin Peay State University Director of Athletics Gerald Harrison again turned to a young coach who has risen through the ranks and gained a reputation as a diligent recruiter to lead one of the department's flagship programs. In March, the APSU athletics department introduced Brittany Young as the 11th head women's basketball coach in program history.

Young takes over the Austin Peay women's basketball program after a season as assistant coach and recruiting coordinator at Mississippi State. She helped sign KN'isha Godfrey, a fourstar-rated recruit by espnW and the No. 8 point guard in the country.

"I am truly honored and grateful to join the Austin Peay family and to become a part of the Clarksville community," Young said.

"There is great leadership at Austin Peay State

University, and I would like to thank Director of Athletics Gerald Harrison and President Michael Licari for believing in me and my vision for this program. I look forward to connecting with our student-athletes as we strive to achieve excellence."

When Mississippi State head coach Nikki McCray-Penson moved to Starkville after three seasons at Old Dominion, Young joined her. The pair led a successful three-season turn at Old Dominion where they helped the program reach its first postseason appearance since 2015 amid back-to-back 20-win campaigns.

"Brittany was a student-athlete at the Division II level and has coaching experience at the junior college, mid-major and Power 5 levels, giving her a wealth of experience to draw from – she'll be prepared for anything the game can throw at her," Harrison said.

Govs win first-ever OVC Beach Volleyball Championship

Austin Peay's beach volleyball team won the first-ever Ohio Valley Conference Beach Volleyball Championship in April, sweeping UT Martin, 3-0, in the title match at Skyhawk Beach Volleyball Complex in Martin, Tennessee.

After the Govs on-court celebration wrapped up, the OVC named Jenna Panning, Brooke Moore, Tegan Seyring and Kelsey Mead to the inaugural OVC Beach Volleyball All-Tournament Team. Moore and Panning were also named the tournament's MVP pairing after going 3-0 and scoring two match-clinching points for the Governors.



Women's Tennis wins second OVC title

Austin Peay's women's tennis team won its final three singles matches for a comeback victory against top-seeded Southeast Missouri in April. It was the Governors second-straight Ohio Valley Conference Women's Tennis Championship.

"It feels wonderful," Coach Ross Brown said. "It's a little bit of relief, but a lot of joy, and I am extremely proud of how our women fought out here. They truly did leave everything out here; there is nothing left."

The team went on to play in the NCAA Tournament, losing in the first round to No. 3 Georgia.

Taylor trains with Pacers

Austin Peay State University men's basketball legend Terry Taylor will begin his professional career with the Indiana Pacers, who inked the Bowling Green native to a training camp deal minutes after the 2021 NBA Draft concluded.


Taylor, the two-time defending Ohio Valley Conference Player of the Year, will join the Pacers for training camp and their run in Las Vegas for the MGM Resorts NBA Summer League 2021, which begins Aug. 8.

"I'm grateful that the Pacers are taking a chance on me, and I'm going to do my best to make sure they don't regret giving me this opportunity," he said. "I'm excited to start my career; I've been dreaming about this since I was a kid and for it to be a reality is just surreal for me."

Taylor's case as one of the greatest players in league history continued to gain steam over the course of his career,



culminating in a senior campaign that saw him shatter Austin Peay's career scoring record and become just the fifth player in Ohio Valley Conference history to score 2,000 points and grab 1,000 rebounds in his career. In the history of NCAA Division I basketball, Taylor is one of only 120 players to reach that milestone.



Spain drafted to MLB

Austin Peay State University center fielder Garrett Spain became the 44th Governors player drafted in the Major League Baseball Draft when the Toronto Blue Jays selected him with their 15th round selection earlier this summer.

Spain becomes the ninth Austin Peay baseball player selected in the 15th round or earlier. He is the first to be picked that early since both Ridge Smith (12th round, Toronto) and Logan Gray (13th, Kansas City) were selected in the 2016 draft.

Spain made a move up to First Team All-OVC in 2021 after earning OVC Freshman of the Year, Second Team All-OVC, and OVC All-Freshman Team honors in 2019. He closed the 2021 regular season strong – batting .359 with 14 RBI over the final 19 games. He finished the season batting .330 while leading the Govs in home runs (9), RBI (43), and stolen bases (14).

During the COVID-19 pandemic, the APSU Candlelight Ball co-chairs, Kathryn Minniehan and Kayla Morgan, persevered to host a successful virtual event in place of the traditional, in-person ball. before the event, the pandemic forced them to cancel. In spring 2021, with health and safety still a concern, they hosted a successful virtual event that raised money for important student scholarships.

APSU PHILANTHROPISTS OF THE YEAR THE BAND FOUNDATION



A chance invitation to the 2016 Mid-South Prairie Symposium at Austin Peay State University sparked Clark Mitchell's interest in the Southeastern Grasslands Initiative (SGI), a collaborative effort led by the APSU Center of Excellence for Field Biology to restore and protect an endangered ecosystem that stretches across 18 states. Mitchell, secretary for the Band Foundation, was seeking to

invest in a new organization that would help create a new conservation movement. With an initial \$20,000 planning grant in 2016, the BAND Foundation instructed SGI Executive Director Dwayne Estes to create a multi-year plan and to "dream big." The BAND Foundation's support of SGI has now reached over \$1 million in matching challenge grants, establishing SGI as one of the most important conservation movements in the Southeastern United States.

Joe Shakeenab ('04, '14), APSU Military Alumni Chapter president and APSU National Alumni Association president, enlisted in the U.S. Army as an Airborne Ranger in 1982. From there, he went on to an impressive, 28-year military career, culminating with his service with the 5th Special Forces Group.

He served extensively in the Middle East and the Horn of Africa, where he participated in, directed and supported numerous operations. Lynn Von Hagen is a native of the Nashville area. She is in the final year of her Ph.D. program at Auburn University (AU) in the School of Forestry and Wildlife Sciences. She is an advocate for women in STEM and nontraditional students, as she began her academic journey later than most.

In 2015, Von Hagen earned her bachelor's degree in biology from APSU with an emphasis in zoology. She performed her undergraduate research with Dr. Stefan Woltmann.

Von Hagen went on to Western Kentucky University (WKU) to complete her graduate studies and began her life-changing work in the Tsavo ecosystem of Southeastern Kenya, where she and other researchers work to find paths to coexistence for people and African elephants, and quantify biodiversity in the Kasigau Wildlife Corridor.

After receiving her master's degree in biology from WKU, Von Hagen was awarded the Presidential Research Fellowship at AU, where she continues on the same project in Kenya with a new focus. Her permanent home is in Nashville with her husband Todd and their two cats. After her graduation in 2022, Von Hagen hopes to work for a conservation NGO or a research group managing programs that address the dual crises of climate change and biodiversity loss.

John McGee is a Hopkinsville, Kentucky, native. After high school, he served in U.S. Army for six years. McGee then earned his bachelor's degree in economics from APSU in 1969 and also served as SGA president.

McGee worked for 20 years with Chilton Corporation as vice president of marketing and 10 years with CSC Credit Services in Houston, Texas, as the senior vice president of sales and marketing until his retirement in 2004. He co-founded ER Centers of America in 2006, which operated free-standing emergency medical facilities in Texas.

McGee previously served on the APSU National Alumni Association Board of Directors. When he visits Clarksville, he regularly speaks to APSU economics and finance classes.

In 2019, he donated more than \$50,000 in gold coins to APSU to establish the Golden Eagle Graduate Scholarship Endowment for APSU students. The gift commemorated his "Golden Graduate Year," the 50-year anniversary of his APSU graduation. He and his wife Janet also established a scholarship to be awarded each year to one male nursing student who has served in the military. They have two daughters and two grandsons, and they live in Highland Village, Texas.


