In the fall of 1914, a young Clarksville lawyer named Austin Peay joined a men's league dedicated to the cause of women's suffrage. It was a risky move for the budding politician, but by following his convictions, Peay found himself on the right side of history. Six years later, on Aug. 18, 1920, Congress ratified the 19th Amendment, giving women the right to vote.

"Women do not shirk responsibility," Peay said in March 1922, at the launch of his gubernatorial campaign. "Some of them did not want the ballot, but it is theirs, and they should not evade its use."

Nearly a century later, the school that now bears his name – Austin Peay State University – is continuing his legacy by encouraging generations of students in their educational pursuits and to take advantage of

generations of students in their educational pursuits and to take advantage of opportunities of civic engagement. Gov. Peay said women possess a "patient courage," and examples of this courage have flourished throughout the University's history.

Hattie Clay Walker exemplified this courage when she arrived on campus in 1956 as Austin Peay's first African American female student. A year later, she graduated with a Master of Arts in Education. In the late 1970s, Maggie Kulback was elected the first female president of Austin Peay's Student Government Association, which made her the first female SGA president at a Tennessee public university.

A few years later, history professor Betty Joe Wallace helped transform this institution by founding and serving as director of both the African American Studies and the Women and Gender Studies programs. Around that same time, Dr. Carmen Reagan became the first female dean of the College of Business. She continues to inspire and empower women on this campus through the Reagan Giving Circle, an organization that provides scholarships to female students at the University while encouraging women as philanthropic leaders.

Their contributions, along with the work of thousands of other women over the years, have contributed to Austin Peay's distinct culture, one we all cherish. In this issue of the alumni magazine, we celebrate the women innovators working and studying on campus today. You'll read about Dr. Amy Wright's nationally lauded essays on insects as a food source and how alumna and instructor Kelley Price is using her culinary talents to create award-winning wine. You'll learn about two undergraduate women who discovered famous works of art in the University's private collection, and you'll get a sneak peek at what several members of the APSU community are doing to commemorate next year's 100th anniversary of the 19th Amendment.

Two years after the passage of that amendment, Austin Peay called on the state's newest voters to fight for "higher ideals in Tennessee," and as you'll see in this issue, the women innovators at his namesake institution are continuing to do just that.

OUT-OF-STATE TUITION CUT NEARLY IN HALF

Austin Peay State University – Tennessee's fastest-growing public university – is looking to attract more students from other states by drastically cutting its out-ofstate tuition. For years, students living outside Tennessee paid about \$11,000 per semester, but a new rate approved by Austin Peay's Board of Trustees cuts that amount nearly in half to just under \$6,200 for 12 credit hours.

Dr. Rex Gandy, APSU provost, recommended the 43.5 percent out-of-state tuition reduction as a way of improving diversity at the regional university.

"The majority of our students are from the Clarksville-Montgomery County area," he said. "It's important for us to attract students from other states who bring different perspectives, culture and knowledge to our campus."



FIRST PAYLOAD IN SPACE

At about 4:30 a.m. CDT Thursday, June 20, Austin Peay State University's first-ever space payload launched on a NASA suborbital rocket. Austin Peay physics professor Dr. Justin Oelgoetz and two APSU physics students – Zach Hill and Zach Givens – built the predesigned payload during Rocket Week at NASA's Wallops Flight Facility in Virginia.



ROTC FINISHES STRONG AT SANDHURST

The ROTC Ranger Challenge team cadets elevated Austin Peay to a world-class level by finishing eighth among ROTC teams at the international Sandhurst military-skills competition. The team beat schools such as Florida State, Embry-Riddle and Johns Hopkins.



JONES NAMED COAL DEAN

Barry Jones, former chair of the APSU Department of Art + Design, was recently named dean of the University's College of Arts and Letters. Jones is a talented artist working in digital media, and he has exhibited work in galleries and museums across the country.



BROWN NEW COBHS DEAN

Dr. Tucker Brown, former chair of the APSU Department of Sociology, was recently named dean of the University's College of Behavioral and Health Sciences. Brown is a well-regarded academic, having published several scholarly articles and delivered more than 17 conference presentations.



NEW DOCTORATE IN THE WORKS

During its spring meeting, the University's Board of Trustees approved moving forward with a Doctor of Psychology degree in counseling psychology with a concentration in serving military personnel, veterans and their families. The program still needs SACSCOC approval.

DR. CHRISTOPHE KONKOBO NAMED FULBRIGHT SCHOLAR

The U.S. Department of State recently named French and Francophone studies associate professor Dr. Christophe Konkobo a prestigious Fulbright Scholar. He will spend the 2019-20 academic year teaching and conducting research in the West African country Burkina Faso.


"I'll teach what is known as American culture, they call it more specifically 'American Civilization,' and my niche in that particular field is African American pop culture, film and theater," he said.

He'll also research acting and filmmaking in French-speaking (Francophone) Sub-Saharan countries. His goal is to write a book on the topic, following up on his book about theater in Burkina Faso titled "La Pratique du Théâtre Moderne au Burkina Faso" ("The Practice of Modern Theatre in Burkina Faso").



VA BENEFITS BOOST HELICOPTER PROGRAM

Austin Peay's aviation science program recently received approval for veterans education benefits, meaning veterans can earn the degree at "little or no cost." The program, Tennessee's first rotorcraft flight bachelor's degree, also received provisional FFA approval.

AUSTIN PEAY SENDS OFF DOLLS TO CELEBRATE WOMEN IN STEM

ustin Peay State University and the College of STEM recently celebrated women in science by launching a high-altitude balloon carrying two dolls adorned in American Girl NASA space suits.

The dolls reached 93,914 feet at 11:13 a.m. Jan. 24. Balloon project team members hoped the launch helped raise awareness about the challenges of women rising in their fields of study.

"While growing up, I never really thought of myself as being good at mathematics or physics, the really difficult STEM fields, but being able to do this and having a successful launch, being the lead on it, having that responsibility, it feels good," Megan McCracken, team leader for the High-Altitude Balloon Team, said.

McCracken is pursuing a degree in physics after earning a master's in genetics and parasitology. Her goal is to become a professor, educating the next generation of scientists.

"Today was for the women of STEM, getting our name out there and saying we support the women of science, that we support anyone in science, that they have the potential to achieve big things in their field," she said. "It was having that picture of women in astronaut suits, being out there with the curvature of the Earth."

The team launched the balloon at 9:52 a.m. Jan. 24 from the Austin Peay Farm and Environmental Education Center on Pickens Road in Clarksville.

There were crickets in the risotto. Dr. Amy Wright, professor of languages and literature, knew the insects were dead, but something about their small faces bothered her.

"These were whole crickets, and they appeared to be looking back at us," she said. "I said, 'I don't know if I can do this.""

Wright had toyed with the idea of tasting a bug ever since the United Nations issued a report identifying insects as a potential food source for humans. She knew if she ever hoped to write about it, she'd have to eat a bug. So Wright scooped up a fork-full of cricket mushroom risotto, ignored the little face staring at her, and took a bite.

The evening marked the beginning of a new

creative journey for the Austin Peay writing professor. In the years that followed, her essays about entomophagy – eating bugs – have appeared in prestigious journals and magazines across the country, and in March, Iris Press published "Think I'll Go Eat a Worm," a chapbook of her essays.

"Wright is masterful at drawing you into her world, and everyone could benefit from taking a quiet moment to join her there," anthropologist and author Julie Lesnick said.

Students Discover Works from

Two Najor Artists



As Austin Peay freshman Sarah Potter combed through the University's art collection in early February, she came across a photo of a man sitting on a rock, his back to the camera.

"I was looking for personality, for stories," Potter, who's curating an exhibit for the walls of Human Resources in the Browning Administration Building, said. "I liked it, so I set it aside with the other photographs."

University records listed the photo as "Artist Unknown" and "Title Unknown." Within hours Potter and University gallery director Michael Dickins identified the man in the picture as



Winston Churchill and the photographer as American portraitist Philippe Halsman.

Halsman's signature is on the back of the Austin Peay print along with the photographer's instructions to the printer: "More contrast please! This cropping."

Potter's discovery was the second major finding this year in Austin Peay's Permanent Collection. A week earlier, Austin Peay junior Katherine Tolleson

discovered two drypoint creations by French artist Alphonse Legros.

Tolleson's discovery happened as she helped Dickins remove acid mats from artwork (the acid stains paper).

> "I came across this one (a drypoint of a bearded man in a hat), and I couldn't quite tell if the mat was acid or not, so I checked with Michael," she said. "As we were taking it apart, we noticed some interesting things about it."

Alphonse Legros' signature was clear. Below that was the image's title, "The Sailor."

And below that Legros writes the image is one of only 10 imprints.

Busy Education of the semester as a legislative intern in the

Sierra Salandy's last year in college typifies her entire time at Austin Peay. She started off the semester as a legislative intern in the Tennessee General Assembly. And during her first week on Capitol Hill, she found out she'd won the crown of Miss Black Tennessee US Ambassador.

The political science senior represented Tennessee in the Miss Black US Ambassador pageant last summer in Atlanta, Georgia.

"Finding out during orientation week of the internship, that moment in itself was so surreal," Salandy, who graduated from Siegel High School in Murfreesboro, said. "My platform for the pageant is to promote more women to get involved with politics, law and government."

In addition to finishing off her degree at Austin Peay this year, Salandy served in Sen. Brenda Gilmore's office in Nashville during the legislative session and traveled around Tennessee in her role as Miss Black Tennessee US Ambassador.

Her political ambitions and pageant platform align nicely.

"My platform for the pageant is to promote more women to get involved in politics, law and government.))

"I'm a huge advocate for women empowerment, and I want to be a role model for young women, especially young black women, because I love inspiring others, and I'm very passionate about community service, diversity and sisterhood," Salandy said.

"Politics is so powerful and impactful. It affects me. It affected my ancestors. It affects all of us."

She cherishes her experience at Austin Peay.

"I feel like I've learned a lot about myself. I've definitely learned a lot about politics. It's challenged me in all the right ways."

he stream beds on the Tennessee side of Fort Campbell harbor a rare treasure, a rustybrown crayfish with white-tipped claws that exists nowhere else in the world.

Former Austin Peay State University graduate student Erin Bloom led the research that identified the crayfish as a new species. She and her teammates named the new species the Screaming Eagle Crayfish in honor of the troops of the 101st Airborne Division.

"That was probably one of the most overwhelming parts of this for me was trying to come up with a name," Bloom, now a biology professor at Volunteer State Community College in Gallatin, said. "We knew we wanted to pay tribute to where the crayfish is found. Because the majority of them are found on Fort Campbell, we thought it would be perfect."

Even the Screaming Eagle Crayfish's scientific name salutes the 101st Airborne. Faxonius bellator loosely translates to "crayfish warrior."

Bloom's research determined the crayfish lives in only three streams on post and one stream at Billy Dunlop Park in Clarksville, where it's seemingly rare. She and her teammates - APSU biology graduate Brittany McCall, APSU biology professor and Center of Excellence for Field Biology Principle Investigator Dr. Rebecca Blanton Johansen and retired Eastern Kentucky University biology professor Guenter Schuster – published their work Jan. 7 in the Journal of Crustacean Biology. The APSU Center of Excellence for Field Biology supported the research.

"It's not something you'd think you can do as an undergraduate, participating in research like this," McCall said. "To pay homage to my hometown, and to my Fort Campbell family, is important to me. It feels good to give back in any way I can."

Chef Kelley Price ('14), a former U.S. Marine Corps military police officer, thinks she might be a bit twisted. Not in a bad way. She's just easily bored and likes to mix things up a bit. This happened a few years ago, when she first started work as an instructor in Austin Peay State University's Culinary Arts program.

"I taught the bar service and bar management class, and one year, I said, 'Why can't we do more with the program?'" she said. "So we incorporated making beer and wine. That class now fills up first every time."

When the class first started, Price didn't know how to make the beverages. But a friend donated a couple of kits, and after doing her own research, and a little trial and error, she figured it out. Once she was able to teach her class the basics, her mind began wanting to twist things around again.

"I went in and started experimenting, making my own flavors," Price said.

Why not add green apple flavoring to Riesling or develop a basil lemonade wine? If those sound strange, you should try her blueberry white merlot or melon berry pineapple cucumber wine. Price bottled her creations under the label Twisted Wines and submitted them to the Tennessee Viticultural Oenological Society's annual wine making competition.

"I entered one bottle, and I won silver," she said. "That's when I said, 'This is pretty cool,' so the following year I entered six bottles and won five – three golds, a silver and a bronze."

Now, Price has 500 bottles of wine aging at her farm in North Clarksville, and in the next few months, she plans to open Twisted Winery on the property.

NEW DOCTORATE HAS STRONG FIRST YEAR

Michael Johnson ('13,'14, '17), a Northwest High School music teacher, can't stop thinking about leadership strategies. For the last year, he's fixated on the topic, causing him to scrutinize his conversations with students and colleagues.

"A year ago today, I would never have analyzed it as much as I do now," Johnson said. "The way I view things now is from the lens of 'What's the leadership style? Why is this working or not working?' I'm not in a leadership role yet in the school system, but my thinking has translated into my classroom and my interactions with other teachers." Johnson developed this new mindset last August when he became one of Austin Peay's first doctoral students. He, along with 19 others, enrolled in the Eriksson College of Education's new Doctor of Education (Ed.D.) degree program, with a focus on educational leadership. After the program's first year, he remains committed to one day being called "Dr. Johnson."

"This is very well established, with high expectations," he said. "They're not going to just hand you a degree. You're going to have to work for it. That's exciting."



Dr. Gary Stewart ('70), professor of education, spent the last several years developing the program because of a growing demand from local educators. Last summer, he made sure they enrolled only the top candidates.

"They're everything we thought they would be," he said. "We knew almost 99% of them because they came through either our Ed.S. program in leadership or they came through one of our graduate programs. We knew the caliber of students we were getting."



CELEBRATING A TENNESSEE TRIUMPH





On a July afternoon in 1914, more than 75 people crowded into a house on Madison Street for a meeting of the newly established Clarksville Equal Suffrage League. The women who joined the league that afternoon spent the next six years facing ridicule and threats of violence in the pursuit of their goal – earning women the right to vote. In that time, they helped Tennessee become the 36th state to ratify the amendment, providing suffragists with the threefourths majority needed to amend the constitution.

On Aug. 26, 1920, the 19th Amendment became part of the U.S. Constitution.

Next August marks the 100th anniversary of that historic event, and the upcoming centennial caused several women within the Austin Peay State Kanervo and Brenda Harper, a member of Clarksville's 2020 Vision Committee for the anniversary, put together a group of 20 women leaders, and the group began soliciting artists for the project. The committee ultimately picked Phoenix and Nashville-based artist Roy Butler's design, featuring a woman casting her first vote. The group nicknamed the statue Tennessee Triumph.

"Roy talked with us and made it unique to Clarksville," Kanervo said. "Her hat is based on a hat worn by Pearl Darnell Perkins, who was a Clarksville suffragist. The dress was from an ad in the 1920s The Leaf-Chronicle. The purse was carried by a bride in Clarksville in 1920, and the boots were from the museum collection."

University community to look at commemorating the event. Ellen Kanervo, retired APSU professor and director of the Arts and Heritage Development Council, decided her hometown needed to be part the Women's Suffrage Heritage Trail through Tennessee, which stops at monuments in Knoxville, Nashville, Memphis and Jackson.

"I thought, well if they're on the heritage trail, Montgomery County needs to be on the heritage trail," she said. "We need to have a statue." The group is currently soliciting funds to pay for the 7-foot-tall statue, which will be placed at the top of Public Square. Once the project is complete, Kanervo hopes all women will be able to look at Tennessee Triumph and see themselves in the statue.

"This is every woman," she said. "We asked Roy to please make it so anyone can see themselves in this monument, regardless of age or race. If you look at her, I think she manages to get that. I really like it."

A SECOND CHANCE AT **GRADUATION**


Twins Claudia and Lidia Yanes Garcia stood shoulder to shoulder adorned in graduation caps and gowns May 6 in Austin Peay's Iris Room as the University's top leaders took turns honoring them.

The twins didn't say much, other than a Spanishaccented "thank you" here and there, but their smiles shined – as their smiles always do – and that spoke loudly and clearly.

For four years, the Yanes Garcia twins from Los Realejos, Spain, played tennis side by side for Austin Peay, lifting the Governors to an OVC tennis championship earlier this year. They also studied side by side, both earning 4.0 GPAs en route to computer science degrees.

The four-year journey culminated in May in the Iris Room as the University held a special graduation ceremony for the twins. They missed their May 3 commencement because they were leading the Governors in the opening round of the NCAA tournament.

"We're really proud of you," APSU President Alisa White said. "We're proud of your academic performance. We're proud of the way you conducted yourselves here. It had to be tough so far from home,



but you were just model students, model citizens, model athletes."

The twins' smiles never wavered.

"I feel so good," Lidia Yanes Garcia said. "I didn't expect to do graduation because when we won the OVC, we knew we were going to miss graduation day. We're so proud to be here today. Everybody is here."

Her sister, Claudia, laughed: "I felt like everyone was looking! But I felt good because that means we've been four years studying and we have something."



RACKEL NAMED GOOGLE CLOUD ACADEMIC ALL-AMERICAN

In June, Governors pitcher Morgan Rackel was named to the 2019 Google Cloud Academic All-America Division I Softball First Team as selected by the College Sports Information Directors of America. Her selection marks the first time a Governor has earned first-team honors in program history and the fourth-time overall a softball Gov has been selected as an Academic All-American.

Parker Phillips and pitcher Greg Leban saw their names on the draft board during Day 3 of the 2019 Major League Baseball Draft. Leban was selected in the 31st round by the Atlanta Braves.



HOLT INDUCTED TO OVC HALL OF FAME

Cheryl Holt, who served in the University's athletics department in various roles for nearly 35 years, was inducted into the Ohio Valley Conference Hall of Fame during a special ceremony in May. Inducted into Austin Peay's Athletics Hall of Fame in 2012, Holt joined the Governors athletics program in 1982 as a tennis coach but was tapped by then-Director of Athletics Johnny Miller to elevate the volleyball program. In 23 seasons, she amassed 364 career wins as the Govs volleyball head coach, with 19 consecutive OVC tournament appearances and won the tournament title in 1991.



BEST-EVER FINISH IN OVC COMMISSIONER'S CUP

Behind two regular-season championships and another pair of Top 3 finishes in Ohio Valley Conference play, Austin Peay's athletics department posted its best-ever finish in the 2018-19 OVC Commissioner's Cup. The Governors strong showing in the Commissioner's Cup included its OVC championship volleyball and women's tennis programs. In addition, the Governors baseball team and women's outdoor track and field teams each posted Top 3 finishes. Austin Peay also earned Top 5 finishes from men's basketball, women's basketball, men's golf, softball, women's indoor track and field and women's golf.

Throughout the spring and summer months, our Austin Peay family has had much to celebrate.

By the end of the 2019 fiscal year, we received more than \$10 million in gifts and pledges from alumni, friends and community members like you. This achievement is exciting because that total surpassed the \$9.85 million raised in 2018, making 2019 the second-highest giving year in University history. We are thrilled that so many donors are investing in student success, including two of our own retired faculty members – Dr. Susan J. Kupisch and Dr. Camille Holt – who both established new endowments to benefit APSU students. Dr. Kupisch

created the Dr. Susan J. Kupisch Psychology Endowment to help psychology majors maximize their potential and prepare for life after graduation, while Dr. Holt created the Jo and Isaac Buck Endowment, in memory of her late parents, to assist students with a major in education for reading specialists.

More than 600 alumni and supporters attended the 35th Annual Candlelight Ball on March 16. Over the years, this University tradition has provided more than 25 Austin Peay students with financial assistance and scholarships thanks to the generosity of underwriters and guests.

In April, the University's third annual 72-hour online giving event, known as Govs Give, contributed \$224,550 to the APSU colleges' Funds of Excellence, athletics and student affairs. These innovation funds allow deans and directors in academic and student areas to provide students with valuable tools and hands-on learning opportunities. The total impact of Govs Give is currently \$547,080 raised and 349 new donors recruited within the last three years.

Some of our newest alumni have started a legacy of giving as well. The APSU Senior Class of 2018 came together to donate more than \$8,000 in scholarship funding for future generations of students. The class reached this achievement by purchasing stoles and cords to wear at graduation and personalized brick pavers to be placed on the John Morgan Walk of History on the APSU campus. In total, 233 donors contributed. They were given special recognition at the Senior Toast on April 29.

We are also excited for Govs Night Out, a unique new event designed to bring together women in the Clarksville community, which will take place this Oct. 10, in the ECHO Club Power Level of Fortera Stadium. The event will serve as a fundraiser for the Austin Peay Athletics nutrition program. The program provides healthful nutrition support to the 350 student-athletes on all 16 of APSU's sports teams. During Govs Night Out, guests will enjoy wine, food, a fashion show, a special gift and a tour of APSU Athletics facilities.

Thank you for all the ways you work to support APSU. We are proud to share our success with so many outstanding alumni and friends.



DEE BOAZ



GIVE BACK TO APSU THROUGH A CHARITABLE IRA

Did you know that after age 70 ½ annual withdrawals are required from traditional retirement accounts? After years of contributing to your tax-deferred 401(k) and IRA (individual retirement account), income tax will be due on that money when you take withdrawals in retirement. The penalty for skipping a required minimum distribution is 50 percent of the amount that should have been withdrawn. However, if you don't need your distribution to cover living expenses, you can avoid income tax by donating your money directly to Austin Peay.

Just have your IRA trustee directly transfer funds from your IRA to Austin Peay to qualify for the tax break. If you withdraw the money from your IRA and donate it later, it will not qualify as a tax-free qualified charitable distribution.
