Thank you for your interest in the Austin Peay State University (APSU) Master of Social Work (MSW) Program (accredited by the Council on Social Work Education).

NOTE: There are **two options** for our MSW program: our <u>regular standing program</u> (60 hours) and our <u>advanced standing program</u> (30 hours).

<u>Regular Standing (60 hours)</u>: You must meet the following requirements to be eligible for regular program admission:

- 1. Graduation from an accredited college or university, with a bachelor's degree which includes coursework in the area of liberal arts
- 2. A cumulative GPA of 2.75 or higher

<u>Advanced Standing (30 hours)</u>: You must meet the following requirements to be eligible for advanced standing admission:

- 1. Graduation from an accredited College or university, with a bachelor's degree in social work, accredited by the Council on Social Work Education.
- 2. A cumulative social work GPA of 3.0 or higher.

Enrollment is limited.

Review of completed applications begin February 1, 2024

Application Process for the MSW requires two steps:

- (1) Apply to the College of Graduate Studies. The application for the College of Graduate Studies is completed online. Your transcripts must be sent to the College of Graduate Studies. Notification of Admission Status

To be accepted into the program, you must meet the admissions requirements of both the College of Graduate Studies and the MSW program. This administrative process is as follows:

- The College of Graduate Studies will determine whether you meet the minimum (1) qualifications for admission to graduate studies and will notify the MSW Admissions Committee.
- The MSW Admissions Committee will review those applications approved by the College of (2) Graduate Studies as meeting minimum admission criteria, select the individuals for admission, and notify the College of Graduate Studies of the decision.

You will be notified by email regarding your admission status by the end of April. You may be placed on a wait list or offered admission for other than what you requested.
