• ENGL 5460 - Graduate Literary Journal Internship

Old Description:

This internship offers selected students the change to put literary editing into practice. The Practicum includes a training period to establish evaluation criteria for publishing. After this orientation, students appraise, and provide written and oral feedback on each submission. Participants also complete a personal narrative essay about the editorial process.

New Description:

In the Fall, this hands-on opportunity to learn publishing consists of crafting application material for internal editorial positions, attending meetings to establish evaluation criteria, reading, voting, and providing commentary on weekly submissions, and completing a reflection paper about this learning experience.

In the Spring, students continue their work with Zone 3 in preparation for the Zone 3 Writers Festival in the summer. Students gain practice with budgets, event planning, coordination with visiting authors selected the previous Fall, and collaboration with festival speakers and attendees.

Department of Languages and Literature - represented by Dr. Florian Gargaillo

Graduate New Course

Final approval required by Provost/SVP Academic Affairs

- 1. ENGL 508E Social Issues in Writing
 - This course analyzes the structures of power and the important role of writing to support vulnerable and stigmatized populations' freedoms. It covers several theories pivotal in identifying oppression. It also covers ways to forward social issues through equitable writing practices.
- 2. ENGL 5800 Advanced Digital Writing
 - This course covers the theories and practices involved in today's digital writing environments, which applies to all industries. It emphasizes digital writing in the field of technical writing specifically.

Dr. Florian Gargaillo explained they are proposing two new courses and there are three faculty willing and able to teach these courses.

Dr. Maria Cronley asked if these were going to be electives for the graduate programs? Answer: Yes, they are and at this time no courses are being removed but the program will be looked at next year to determine if any of the electives should be removed.

- 3. Choral Conducting, Music MMU
 - Removing an incorrectly listed course of MUS 5430 (Chamber Music Literature) and adding the correct course of MUS 5340 (Music from 1750 to 1900).

Implementation Fall 2025

- 4. Instrumental Performance, Music MMU
 - Adding MUS 5310 (Survey of Piano Literature) to the complete nine hours from section of the MUS electives.
 - Adding MUS 5215 (Music Pedagogy in Practice) to the complete five hours from section of the MUS electives.

Dr. Rob Waugh presented two small changes to the graduate Music program. One corrects a course that was incorrectly listed in the bulletin. The second is to added two courses to elective possibilities for students pursuing piano pedagogy.

Dr. Maria Cronley asked if these courses were already in existence? Answer: They are currently on the books but not currently electives in this program.

Department of Criminal Justice- represented by Dr. Scott Culhane

Undergraduate Program Modification

Final approval required by the Provost/SVP Academic Affairs

- 1. Homeland Security Minor
 - Adding CRJ 4400 (Critical Issues in Border Security) as an elective in the minor.

Dr. Scott Culhane explained this is just a correction to put a courses into the minor that was inadvertently missed on a previous update.

- 2. National Security Studies, BS
 - The concentrations of Corporate Security, Geographic Information Systems, and Intelligence are temporarily being suspended due to low enrollment numbers. Students will be filtered into a BS National Security Studies major which will create a path allowing students to graduate in a timely manner and receive a general degree in the field.
 - Lower division requirements will remain the same while upper division requirements will add three additional courses (NSS 3100- Conflict Management and Peace Operations; NSS 3420 Genocide and International Crimes; and NSS 4600 Fundamentals of War) to the required courses, with the remaining major requirements being a range of electives tailored to the student's interest.

Dr. Scott Culhane explained they are correcting the NSS major as it is currently unattainable with the

concentration. This will streamline it and give them choices toward graduation so they don't need multiple concentrations and will ensure they are able to graduate.

Undergraduate New Course

Final approval required by the Provost/SVP Academic Affairs

- 3. LDSP 4999 Civic Leadership Program Completion
 - This course allows students to earn undergraduate credit for the completion of a formal civic leadership program. These programs are typically administered in an academic year format and sponsored by a local Chamber of Commerce of other civic organization. Examples include: Leadership Clarksville, Leadership Fort Campbell, Leadership Middle Tennessee, etc. Students who wish to be awarded with this credit will be responsible for providing proof of program completion to their academic advisor.

 - As the two concentrations are being terminated, this proposal will move courses from electives to major required courses and from required to major electives.

 - Removing LDSP 4020 (Written Professional Education) from requirements and allowing it to count as an elective.

- 7. LDSP 5999 Graduate Civic Leadership Program Completion
 - This course allows students to earn graduate credit for the completion of a formal civic leadership program. These programs are typically administered in an academic year format and sponsored by a local Chamber of Commerce or other civic organization. Examples include: Leadership Clarksville, Leadership Fort Campbell, Leadership Middle Tennessee, etc. Students who wish to be awarded with this credit will be responsible for providing proof of program completion to their academic advisor.

All items for Leadership were grouped together for one vote.

Dr. Melissa Kates explained that there are two new courses. One is a GR course and the other is a UG course. These courses allow for students who have completed a Civil Leadership program to earn credit for their participation in the program.

Regarding the UG program, the concentrations in Leading Operations and Leading People are being terminated to allow for a more streamlined program. The current concentrations required 39 hours for completion and the new major will require 36 hours for degree completion.

Dr. Tucker Brown asked: Are the two courses variable credit hours: Answer: No, the credit hours are set at 3. There was a second question which was about having to review every portfolio, however, since this was a set credit hour course, that also answered this question.

- 1. BBA Business Core
 - Removing the ACCT 201L (Principles of Accounting I Lab) from the BBA core as the course is being combing with ACCT 2010 (Principles of Accounting I).

Dr. Emily Lean explained that the zero-credit hour accounting lab, which was added fairly recently as a separate course, is being reincorporated back into the regular course and classroom. This update allows for the reduction of work on faculty and the need for GA's to run the labs.

Study Abroad

Department of Study Abroad - represented by Kyle Christmas

Undergraduate New Course

Final approval required by the Provost/SVP Academic Affairs

- 1. APSU 2800 Curricular Practical Training I
 - This course offers international students the opportunity to gain practical work experience in a professional setting, allowing them to apply academic knowledge and skills in real-world environments. Students will engage in meaningful work experience that enhances their understanding of industry practices and workplace dynamics.
 Participants are required to complete a minimum of 15 contact hours per course credit hour, maintain regular communication through bi-weekly updates, and submit a reflective paper documenting their experiences. A satisfactory evaluation from the employer or supervisor is essential for course credit, which will be awarded on a pass/fail basis.
- 2. APSU 2900 Curricular Practical Training II
 - This advanced course builds upon foundational curricular practical training by providing international students with enhanced opportunities for professional development in a workplace setting. Students will engage in more complex projects and responsibilities, allowing for deeper application of academic knowledge. Emphasis will be placed on leadership, strategic thinking, and innovation within a professional context. Students will also enhance their reflective practices and develop a comprehensive understanding of career pathways in their fields of interest.

Kyle Christmas explained that these courses are to allow the F1 visa students to get a paid internship prior to being able to register for a 3000 level course or for students who are majoring in an area that does not offer internships.

These are for semester 1 and 2. The second repeatable in case they do a second internship.
