

Purpose: This form is intended for eligible undergraduate students who wish to enroll in graduate-level courses while completing their undergraduate degree requirements.

Minimum Eligibility Criteria for AMP*

To qualify for the Accelerated Masters Pathway (AMP), a student must:

- Maintain a minimum 3.25 GPA in a major relevant to the intended graduate program.
- Be within one or two semesters of completing their undergraduate degree.

*Please note: Individual graduate programs may have additional or more stringent criteria that take precedence over these minimum requirements set by the College of Graduate Studies. These criteria are not listed on the website and should be discussed directly with the Graduate Coordinator or Department Chairperson for the intended program.

Important Notes:

- Not all graduate programs participate in the Accelerated Masters Pathway (AMP). The following programs are excluded:
 - Master of Nursing (MSN)
 - Master of Social Work (MSW)
 - Master of Counseling
 - Master of Speech-Language Pathology (MSLP)
 - Doctorate in Counseling Psychology (PsyD)
 - Doctorate in Education (EdD)
- Undergraduate students are not officially admitted to the College of Graduate Studies or to any graduate program.
- Poor performance in graduate-level courses may negatively affect students' future admission prospects at APSU or other institutions worldwide.
- Grades earned in graduate courses will not affect the calculation of students' undergraduate GPA.

Procedure for Students:

1. **Consult** with the graduate program coordinator before completing this form.
2. **Complete** the form and submit it to the appropriate graduate coordinator or department chair in the academic department offering the graduate program.
3. **Await notification** from the College of Graduate Studies regarding the approval of your submission. Denial of AMP application cannot be challenged or appealed.
