Formatting

- Margins: 1 inch margins on all sides of the page.
- Font: Times New Roman, 12 pt.
- **Double spaced:** for the content of the paper.
- Single spaced: block quotes
- Page numbers: only the page number flush right.

APA Style Order

- Title Page
- Abstract (if needed)
- Main Body
- References


Title/Cover Page

- Insert a header then add the page number flush right.
- The <u>title</u> should be centered a third of the way down the page.
- Your <u>name</u>, <u>class information</u>, and the <u>date</u> should follow several lines later.
- For subtitles, end the title line with a colon and place the subtitle on the line below the title.
- <u>Double-space</u> each line of the title page.

Order of Title Page:

- Page number
- Title
- Subtitle
- Full Name
- Class Information
- Professor Name
- Date

APA Style 7th Edition - Abstract

Abstract

- Always consult with your instructor if you need to include an Abstract in your written work.
- An abstract is a concise summary of the key points of your research and is typically no more than 250 words and not indented. It is written in a single paragraph and is double spaced.
- Include the page header and type the work "Abstract" at the top of the page, centered, and bold.
- Your abstract will typically include:
 - research topic
 - research questions
 - participants
 - methods
 - results
 - data analysis
 - conclusions
 - possible implications of your research (if needed)
 - future work you see connected with your findings (if needed)
- *Keywords* is a list that will be created at the end of your abstract and helps researchers find your work in databases. It is written in italics followed by a colon. Indent as you would start a new paragraph.

APA Style 7th Edition - Headings & Body

APA Headings

• APA Style holds 5 heading levels to format the sections of a paper. These help guide readers through the written work.

Heading Format

1. Centered, Boldface, Title Case Heading

2. Flush Left, Boldface, Title Case Heading

3. Flush Left, Boldface Italic, Title Case Heading

4. Indented, Boldface Title Case Heading Ending With a Period. 5. Indented, Boldface Italic, Title Case Heading Ending With a Period.

- Thus, if the article has four sections, some of which have subsections and some of which don't, use headings depending on the level of subordination. Section headings receive level one format. Subsections receive level two format. Subsections of subsections receive level three format.
- <u>Example</u>:

Method (Level 1)

Site of Study (Level 2) Participant Population (Level 2) *Teachers (Level 3) Students (Level 3)*

• Section Headings are only included in the body of the paper and are excluded from introduction, abstract, paper titles, references, footnotes, Appendices (use level one headings on these pages and give them their own separate page.

Verb Tenses in APA

- When writing your APA paper it is best to use the following verb tenses:
 - Literature Review (other researchers' work)
 - **Past** \rightarrow <u>Example</u>: Martin (2020) addressed
 - **Present Perfect** \rightarrow <u>Example:</u> Researchers have studied
 - Method (Description of procedure)
 - **Past** \rightarrow <u>Example</u>: Participants took a survey
 - **Present Perfect** \rightarrow <u>Example</u>: Others have used similar approaches
 - Personal reactions
 - **Past** \rightarrow <u>Example</u>: I felt surprised
 - **Present Perfect** \rightarrow <u>Example:</u> I have experienced
 - **Present** \rightarrow <u>Example</u>: I believe
 - Reporting on your results or others \rightarrow **Past** \rightarrow <u>Example</u>: Scores decreased
 - Discussion of implications of results \rightarrow **Present** \rightarrow <u>Example</u>: The results indicate
 - Presentation of conclusions and future directions \rightarrow **Present** \rightarrow <u>Example</u>: We conclude



APA Style 7th Edition - In-text Citations

In-text Citations

- When you are directly quoting the material from another source you must create a citation. This is done to avoid plagiarizing another source.
- Paraphrasing an idea from another work: Authors last name and year of publication.
 <u>Example:</u> (Johnston, 2023)
- **Directly quoting from another work:** Include the authors last name and year of publication and the page number ("p" for one page or "pp" for multiple pages) use the en dash for page ranges.
 - Example: (Jones, 1998, p. 199)
 - Example: (Jones, 1998, pp. 199–201)
- **No page numbers:** reference another logical identifying element a paragraph, a chapter number, a section number, a table number, or something else.
 - <u>Example:</u> A meta-analysis of available literature (Jones, 1998) revealed inconsistency across large-scale studies of student learning (Table 3).
- Include one complete reference for each source in the reference list page.
- Capitalize proper nouns, author names, and initials.
- References list, only the first word of a title will be capitalized: Writing new media.

Short Quotations

- Always include the authors last name, year of publication, and page number.
- You can either include all of this information together or broken up:
 - Example: According to Jones (1998), "students often had difficulty using APA style, especially when it was their first time" (p. 199).
 - <u>Example:</u> She stated, "Students often had difficulty using APA style" (Jones, 1998, p. 199), but she did not offer an explanation as to why.

Block Quotes

(Entire quotation indented

1/2 inch)

- When quoting a source that is 40 words or longer include this information in a block quote.
- Indent 1/2 inch (new paragraph) type the entire quotation. Double space but do not add any extra blank lines before or after.

In Text Format: (Author Last Name, Year)

• Example: (Stoneman, 2008)

Reference Format: Author Last Name, First Initial. (Year). *Title of book:Capital letter also for subtitle*. Publisher. DOI or URL.

• Example: Sapolsky, R. M. (2017). *Behave: The biology of humans at our best and worst.* Penguin Books.

Book by Two or More Authors

In Text Format: (Author Last Name 1 & Author Last Name 2, Year)

• Example: (Dawson & Lucas, 1993, p. 67).

Reference Format: Surname, A., & Surname, A. (Copyright date). *Title: Subtitle* (edition number if applicable.). Publisher.

• Example: Dawson, J., & Lucas, R. (1993). *Lifestyles of New Zealand forest plants* (4th ed.). Victoria University Press.

Book with Three or More Authors

In Text Format: (First Author Last Name, Year, p. Page Number).

Examples:

- **Parenthetical citations:** (Stillings et al., 1995, p. 67).
- Narrative citations: Stillings et al. (1995) argue that ... (p. 67).

Reference Format: Surname, A., & Surname, A. (Copyright date). *Title: Subtitle case* (edition number if applicable.). Publisher.

Example:

Stillings, N. A., Weisler, S. E., Chase, C. H., Feinstein, M. H., Garfield, J. L., & Rissland, E. L. (1995). *Cognitive science: An introduction* (2nd ed.). The MIT Press.

<u>eBook</u>

In Text Format: (Author Last Name, Publication Year, p. Page Number)

- **Parenthetical citation:** (Borras, 2016, p. 65).
- Narrative citation: Borras (2016) notes ... (p. 65).

Reference Format: Author, A. (Date). *Title of eBook*. Name of Publisher. https://doi.org/123.456.789

• Example: Borras, I. (2016). Adult learning for self and relational growth (ALG): An integrative developmental model. Sense Publishers.https://doi.org/10.1007/978-94-6300-417-6

In Text Format: (Author Last Name, Publication Year)

• Example: (Bologna, 2019)

Reference Format: Author(s). (Year, if available). Title of the webpage. Website Name. URL

Example: Bologna, C. (2019, October 31). *Why some people with anxiety love watching horror movies*. HuffPost. https://www.huffpost.com/entry/anxiety-love-watching-horror-movies_1_5d277587e4b02a5a5d57b59e

Musical Score

In Text Format: (Composer Last Name & Librettist Last Name, Publication Year).

• Example: (Picker & McClatchy, 1995).

Reference Format: Composer Last Name, First Initial. (Year). *Title of Score* [Musical score]. Publisher.

Example: Picker, T., & McClatchy, J. D. (1995). *Emmeline: An opera in two acts* [Study score]. Schott Music.

Podcasts

In Text Format: (Host Last name 1 & Host Last name 2, Start Year-End Year or Present)

• Example: (Meraji & Demby, 2016–present)

Reference Format: Host Last Name, First Initial. (Host). (Year, Month Day). *Title of episode* (No. episode number) [Audio podcast episode]. In Producer First Initial. Last Name (Executive Producer), Title of Podcast. Production Company. URL

Example: Meraji, S. M., & Demby, G. (Hosts). (2016–present). *Code switch* [Audio podcast]. National Public Radio.

Religious Work

In Text Format: (Title of the Religious Work, Original Publication Year/Revised Publication Year)

• Example: (The Bhagavad Gita, 2007) & (King James Bible, 1769/2017)

Reference Format: Title of the Religious Work (Publication Year). Publisher. DOI or URL.

Examples:

The Bhagavad Gita (E. Easwaran, Trans.; 2nd ed.). (2007). The Blue Mountain Center of Meditation.

King James Bible. (2017). King James Bible Online. https://www.kingjamesbibleonline.org/ (Original work published 1769)



APA Style 7th Edition - References Page

Journal Article

In Text Format: (Author Last Name, Publication Year)

• Example: (Grady, 2019)

Reference Format: Author(s). (Year). Title of the article. *Title of the Journal, volume number* (issue number), page range. DOI or URL

Example: Grady, J. S., Her, M., Moreno, G., Perez, C., & Yelinek, J. (2019). Emotions in storybooks: A comparison of storybooks that represent ethnic and racial groups in the United States. *Psychology of Popular Media Culture*, 8(3), 207–217. https://doi.org/10.1037/ppm0000185

Reference List

• This appears at the end of the paper to provide the cited information used in the written work. Each entry in the references list must be cited in the paper.

Format:

- **Title:** Reference or References in bold at the center top of the page.
- Double-spaced
- Indent each reference entry by 1/2 inch (hanging ident).
- Alphabetize the entries in a list of last name first.
- When referring to the titles of books, chapters, articles, reports, webpages, or other sources, capitalize only the first letter of the first word of the title and subtitle, the first word after a colon or a dash in the title, and proper nouns.
- Italicize titles of longer works (e.g., books, edited collections, names of newspapers, and so on).
- Do not italicize, underline, or put quotes around the titles of shorter works such as chapters in books or essays in edited collections.

APA Style 7th Edition - Footnotes & Appendices

Footnotes

- Always consult with your instructor if you need to include Footnotes in your written work.
- Footnotes are supplementary details printed at the bottom of the page pertaining to a paper's content or copyright information.

Formatting

- Footnotes should be formatted in numerical order of appearance and do not require a space between the callout and superscripted number.
- Superscripted numerals should follow all punctuation with the exception of dashes and parentheses.
- For dashes and parentheses, place the footnote after the ending punctuation and before the dash or parentheses.

Appendices

• Appendix is included when supplementary content is introduced in a written work. It introduces research materials, specific details of a study, or participant demographics.

Formatting

- Create a new page and title it as "**Appendix**" at the top of the page, centered, and bold. If there are multiple appendices, label each with a capital letter such as "**Appendix B**".
- All appendices should follow references, footnotes, and any tables or figures included at the end of the document.
- They should be in paragraph style and include text, figures, tables, equations, or footnotes.
- label each table in the order of appearance with a letter corresponding to the page and a number such as "Table B1" for "Appendix B".
- If there is only **one appendix in the document**, the visuals should still be labelled with the letter A and a number to differentiate them from those contained in the paper itself (for example, "Figure A3" is the third figure in the singular appendix, which is not labelled with a letter in the heading).
- If Appendix B **only includes a figure**, the figure should be labelled "Appendix B" rather than "Figure B1", as it would be named if there were multiple figures included.
- If an appendix **does not contain text** but includes numerous figures or table, the appendix should be formatted like a text appendix. The appendix would receive a name and label, and each figure or table would be given a corresponding letter and number. For example, if Appendix C contains two tables and one figure, these visuals would be labelled "Table C1", "Table C2", and "Figure C1" respectively.
