ASA Style 7th Edition - Citing Constitution, Laws, & Ordinances

Constitution

In-text Citation Format

- **Paraphrasing:** (Constitution Name, Article/Section Number) or (Abbreviation of Constitution Name, Article/Section Number)
- **Direct quote:** "..." (Constitution Name, Article/Section Number) or ("Quote from Constitution" Constitution Name, Article/Section Number)

Examples

(United States Constitution, Article I)

"We the People of the United States, in Order to form a more perfect Union..." (United States Constitution, Preamble)

Reference Page Format

Full Name of Constitution. Year.

Example

United States Constitution. 1787.

Laws

In-text Citation Format

- Paraphrasing: (Law Name, Section Number) or (Abbreviation of Law Name, Section Number)
- Direct quote: "..." (Law Name, Section Number) or ("Quote from Law" Law Name, Section Number)

Examples

(Civil Rights Act of 1964, Title VII, Section 701)

"It shall be an unlawful employment practice for an employer..." (Civil Rights Act of 1964, Title VII, Section 701

Reference Page Format

Full Name of Law. Year. Volume Number (if applicable). Section Number(s).

Examples

Civil Rights Act of 1964. 1964. Title VII, Section 701.

Immigration and Nationality Act. 1952. 8 U.S.C. § 1101 et seq.

Ordinances

In-text Citation Format

- **Paraphrasing:** (Ordinance Name, Section Number) or (Abbreviation of Ordinance Name, Section Number)
- **Direct quote:** "..." (Ordinance Name, Section Number) or ("Quote from Ordinance" Ordinance Name, Section Number)

Examples

(Clean Air Act, Section 101)

"The purpose of this Act is to provide for the protection and enhancement of the quality of the Nation's air resources" (Clean Air Act, Section 101)

Reference Page Format

Full Name of Ordinance. Year. Section Number(s).

Examples

Americans with Disabilities Act. 1990. Title I, Section 101.

Clean Air Act. 1970. Section 101.
